

TAILORED PLAN LAUNCH



The Department of Health and Human Services announced the new launch date for the Behavioral Health and Intellectual/Developmental Disabilities (I/DD) Tailored Plans. The Trillium Tailored Plan will launch on July 1, 2024.

Beneficiaries who will be covered by the Tailored Plans will continue to receive behavioral health, I/DD, TBI and physical health care as they do today.

TAILORED PLAN IMPORTANT DATES

If your NC Medicaid will move to a Tailored Plan, a letter will be mailed to you in mid-April 2024.

If you have NC Medicaid, your health plan may move to a Tailored Plan if you get services related to:

- 🎄 Serious mental illness (SMI)
- ▲ Severe substance use disorders (SUD)
- Intellectual/developmental disabilities (I/DD)
- A Traumatic brain injuries (TBI)

Didn't get a letter? If you think you should be in a Tailored Plan, call the NC Medicaid Enrollment Broker at 1-833-870-5500 (TTY: 711 or <u>RelayNC.com</u>). You may also need to <u>update your address</u>.

Timeline:

Mid-April 2024

Letters will be mailed to those moving to a Tailored Plan. Some people may get a letter saying they have the choice to move to a Tailored Plan. The letter gives instructions on how to pick a primary care provider. You should <u>check to see if your providers are in your Tailored Plan's network.</u>

May 15, 2024

This is the last day to <u>pick a primary care provider (PCP).</u> If you do not pick a PCP, one will be assigned to you. You can still change your PCP later.

May 16, 2024

You can start scheduling non-emergency medical transportation (NEMT) for appointments on or after July 1, 2024. You can call Trillium at 1-877-685-2415 to schedule rides.

Late May 2024

A welcome packet and new member health plan ID card will be mailed from Trillium. Your primary care provider (PCP)'s information will be included.

July 1, 2024

Tailored Plans begin! Start seeing providers (doctors and specialists) in your Tailored Plan's network.

CONSOLIDATION TOWN HALLS

Trillium now serves 46 counties as of February 1, 2024.

Our primary purpose is making sure our members have the highest quality care, delivered in the right amount at the right time. We will protect care continuity by honoring all provider contracts (for those in good standing and serving members in affected counties). It is important that members remain with their current provider or care manager.

HEALTHY OPPORTUNITIES PILOT LAUNCH



NCDHHS is launching the Healthy Opportunities Pilot for eligible Medicaid members living in certain counties. The Healthy Opportunities Pilot is testing the impact of providing non-medical resources like housing, food and transportation to Medicaid enrollees. Trillium will work with NCDHHS and other designated entities to:

- 1. Help members find the services they need when they need them.
- 2. Make sure there is a diverse group of people participating.
- 3. Improve number of agencies providing these resources.
