Location of sites in either county would be determined by the provider and should be included in the proposal.

4. Why is there a need for an additional OTP provider in Lee County?

The standard set forth by the Department for OTP is  $\geq$  2 providers of each service within 45 minutes or 45 miles of residence for at least 95% of members.
