X. Regional Vice President Report

Victoria Jackson provided updates on Tailored Plan, Medicaid Enrollment Data, Mental Health Parity and Addiction Equity Act of 2008 (MHPAEA), Children and Families Specialty Plan, Child First Expansion, Trillium Health Resources Board Structure and Initial Appointments, NC Department of Health and Human Services Secretary, SB425, and Local Community Updates.

Tailored Plan Update/Medicaid Enrolment Data

Ms. Jackson reviewed the Tailored Plan Operations Report and the Medicaid Enrollment Data Report that was included in the Advisory Board meeting materials.

Ms. Foster requested additional information and data on the Quality Management complaints that are received.

The information on the Medicaid Enrollment Data Report statistics came from the dashboard of the NC Medicaid Enrollment website. It is a breakdown of the number of members Trillium serves that are enrolled in Medicaid and the percentage of members that are covered by the Standard Plan.

Mental Health Parity and Addiction Equity Act of 2008 (MHPAEA)

The MHPAEA is a federal law that requires health insurers and group health plans to generally provide mental health and substance use services with no more stringent benefit limitations than those for medical and surgical benefits.

Ms. Jackson stated that the Clinical Coverage Policy updates that were reviewed by NC DHHS were included in Trillium Health Resources operation by December 31, 2024, as required.

Trillium's CEO, Joy Futrell and Chief Operating Officer, Cindy Ehlers, served as panelists on a Mental Health Parity Kick Off Training on January 21, 2025.

Children and Families Specialty Plan

The Children and Families Specialty Plan is a new single, Statewide Medicaid Managed Care Plan that will wrap Medicaid-enrolled children, youth, and their families currently and formerly served by the child welfare system with seamless, integrated and coordinated health care. In August 2024 NC DHHS announced the contract to operate this plan was awarded to Blue Cross Blue Shield of North Carolina. In January 2025, it was announced that the planned launch date is December 1, 2025. Eligible members that are currently served by Trillium will transition to this new plan at launch.

Child First Expansion

In 2024, Trillium was awarded \$1 million in funding from NC DHHS to expand Child First Services. The provider identified for this service expansion in the South Central Region is Easter Seals. An announcement of the service expansion is planned for February 24, 2025, in the Beulaville location.

Trillium Board Structure and Initial Appointments

Ms. Jackson reviewed the new Governing Board structure that was reviewed and approved by Secretary Kody Kinsley. The new board structure includes fifteen voting members and three non-voting members from the areas of Regional Advisory Boards, Regional Consumer Family Advisory Committee, At Large, Provider, and Health Disparities Council.

The Governing Board will soon elect officers and adopt Bylaws.

NC Department of Health and Human Services Secretary

Dr. Devdutta Sangvai has been named by Governor-elect Josh Stein to serve as NC DHHS Secretary. Dr. Sangvai has an extensive background in family medicine, pediatrics, and psychiatry at the Duke University School of Medicine.

SB425

Ms. Jackson provided an update on the Guilford County lawsuit that was filed in an attempt to maintain the status quo and block the implementation of Senate Bill 425. Currently, the case remains listed as Pending in Wake County Superior Court with no upcoming actions listed.

Local Community

Participation in local community meetings continues through the Regional Vice President, Director of Community Engagement and Empowerment, and the Community Liaison Coordinators. For the month of December, approximately 356 engagements were completed across the 46-county catchment area and approximately eighty engagements were completed in the South Central Region.

The Spring 2025 dates for Victory Junction are April 4-6, 2025, and April 11-13, 2025.

The counties of Jones, Sampson, and Wayne have been selected to move forward in Trillium's inclusive playground grant.

Scheduling for the annual Regional Vice Presidents meetings to present a Trillium update to each county in the South-Central Region is underway.
